
Sound Data

Model 10RESV and 12RESV 8 point logarithmic average sound levels are 67 dB(A) during weekly engine exercise and 71 dB(A) during full-speed generator diagnostics and normal operation. The lowest point sound levels are 64 dB(A) and 69 dB(A) respectively as compared to competitor ratings.*

All sound levels are measured at 7 meters with no load.
